In the spring of 2019 there was a park board meeting to discuss the fields. They were told there was no money in the city budget to improve the fields, but they said there could be fund

raising or the school could pay to update. There was 600 dollars given from local businesses. Last Friday there was a meeting with Mike at the city, Penny, Rob, and Bryce to discuss the west field and improvements that need to be done. Corey described what the company would do if we were to pay them to bring our field up to date. Mike explained that way back the school used to run the summer rec program, however now the city does and the school pays \$5000.00 a year to the city for the rec program. Penny also brought up the differences with the baseball field and the softball field and some title 9 concerns that she has noticed. The dugouts are different, the storage space, the press box, and other items that are not equal. Fundraising was also talked about and the idea of building our own softball field. City did agree to pay for half of the upgrade \$3,100 and agreed the school could pay for upkeep and the other half of the upgrade. The concession stand was also discussed and how the one by the softball field has a lot of issues.

Motion to approve the upgrade for up to \$6,200 and hope the city pays for their half by Stitzer second by Kelly Trumm. Motion carried

- 11.B) Social Media Support -SocialSchool4EDU- Andrea presented her program she has been doing this since 2014. Their mission is to celebrate students. They work with over 60 schools in the state of Wisconsin. They post through the week and monitor even on the weekends.
